**1. PROCEDURE FOR EOI:**

- 1.1 The Corporation invites online EOI for Dealership of **“NARMADA” BRAND LIQUID BIO-FERTILIZER**.
- 1.2 Only one online EOI will be accepted from One Applicant / Firm. If any individual participating in the BID, representing more than one firm in one or different names and it comes to MP AGRO'S knowledge at any point of time, all such BID will not be entertained and shall be liable for rejection.
- 1.3 The bidders intending to participate in this EOI are required to get enrolled/registered on the [mptender.gov.in](http://mptender.gov.in). Enrolment /registration and subsequent empanelment on the above portal and sub portal is mandatory.
- 1.4 EOI documents can be purchased only online from [http:// mptender.gov.in](http://mptender.gov.in) by making online payment of portal fees etc.
- 1.5 It is the discretion of the Managing Director of the corporation to accept/reject the application without assigning any reason thereof.

**2. SUBMISSION OF EOI:**
