TERMS AND CONDITIONS FOR DISPOSAL OF VEHICLES AGAINST TENDERENQUIRY NO.HO/C&S/2022-23/..... DATED 28.03.2023.

Interested Parties may submit their highest prices for vehicle in a sealed cover latest by 3.00PM on or before 17.04.2023. The inner cover containing quotations and other relevant documents along with DD/Pay Order/Banker's Cheque towards EMD should be sealed properly. The cover should be put in another Outer Cover and may be dropped in the Tender Box of C&S Section kept at Reception of the M.P. State Agro Ind. Dev. Corporation Limited, Panchanan Bhavan, 3rd Floor Malviya Nagar Bhopal. Both the inner and the outer covers should be super scribed in Bold Capital letters "QUOTATIONS FOR DISPOSAL OF VEHICLE".

2. The disposal of vehicle shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by this Department. The condition of the vehicle can be inspected physically working day from 29.03.2023 to 13.04.2023 between 11:00AM to 5:00PM at District office M.P. State Agro Ind. Dev. 3. The quotation should be accompanied by earnest money for Rs.5,000/-.The earnest money can be deposited by Bank Draft in favor of M.P. State Agro Ind. Dev. Corpn. Limited Bhopal. The bank draft should be attached with the quotation letter failing which the quotation shall not be considered at all. If the highest tenderer/successful tenderer accepted by the competent authority in this Department fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, EMD deposited by him shall be forfeited.
4. EMD amount is payable by means of DD/Pay Order/Banker's Cheque in favor of M.P. State Agro Ind. Dev. Corporation Limited Bhopal. (Payment by Cheque/Cash shall not be accepted). Offers received without EMD amount shall not be considered at all.

6. EMD of the successful bidder(s) will be released only after realization of Sale proceed amount. Permission to take out the disposed vehicle from premises will not be allowed on holidays/Saturdays and Sundays.
