# 5. QUOTING RATES.

- i. Offerer shall have to quote his lowest rate for the subject items and it should be strictly in accordance with the price fall clause condition mentioned detail in the clause 19 of the RCO document. Offerer shall quote their rates in basic price and G.S.T. separately clearly on FOR Destination bases any where in M.P. Transit insurance if any shall be at the cost of manufacturer/supplier. Any loss of damage of the material during transit whether insured or not shall be made good by supplier free of cost.
- ii. The offerer should quote lowest price in Annexure-6A&6B which is always in accordance with the price fall clause condition mentioned detail in the clause No.19 of the General terms and conditions of RCO Document. The offers will be evaluated on the basis of lowest price. The Counter offer may also be issued by the Corporation only to those offerers whose offer rates are within the limit of L-1+15%.

  - **6. INSURANCE:** Rates should be inclusive of transit insurance. Loss / damage of the item if incurred during transit shall be made good by the supplier free of all charges within 15 days from the date of intimation given by the Corporation. If supplier fails to do so, the Corporation will be free to make the losses good at Offerer cost from all other sources.
  - 7 (i) The price charged for the offered items supplied under the contract by the supplier shall in no case exceed the lowest price on which the supplier sells to other parties private or Government bodies.
    - (ii) If at any time during the said period the supplier reduces the sales price of such offered items or sells such items to any other person/organization at a price lower than the price chargeable under the contract, the supplier shall forthwith notify such reduction in the rate to the Corporation. The price payable under the contract for the item supplied after the date of coming into the force of such reduction in sale price shall stand correspondingly reduced. The Corporation shall be entitled to recover any amount paid to the supplier in excess in respect of sale, which takes place after the reduction of price, by the supplier.

#### 10. ELIGIBILITY CRITERIA

(i) Eligibility and qualification requirements:-

No Offer shall be considered valid if :- The Offerer has not submitted as per eligibility mentioned in Annexure 3 and Clause 9 (1 to 11) of the General terms and conditions.

# 11. VALIDITY OF RATE CONTRACT

The Rate Contract against this RCO is valid up to 31-3-2026 and onwards. The RCO can be extended after the expiry i:e 31-3-2026 till the new Rates are circulated after finalizing the New RCO in this regards. The offerer whose rates will be accepted will have to execute an agreement with this corporation for successful execution of the supplies, within 15 days after issue of letter of acceptance. A Copy of draft agreement is enclosed at Annexure-2.

#### 12. DISPLAY OF SAMPLES.

i. The offerer shall have to essentially display and submit at least one sample of the each Item quoted by them, each sample should be according to the specification & enclose the details of weight of every part

of stove (Burner) for which rate quoted by the offerer upto **12.03.2025 at 12.30 p.m.**.

- ii. The offerer of stove (Burner) shall have to enclose the details of weight of every part of stove.
- ii. The samples thus submitted will not be returned.
- iii. The offers for which samples are not submitted will not be entertained.
- iv. Such offerer whose samples are not found up-to the standard and if rejected, financial bid will not opened. In that case, the decision of the Managing Director will be final and binding on the offerer.

Samples will be inspected by Committee on 12.03.2025 at 3.00 p.m..

#### 13. DELIVERY

Offerer whose rates are approved by the Corporation will have to supply the material ordered against this rate contract by the M.P.State Agro-Industries Development Corporation. The supplies shall be made at the place indicated in the order within 7 days from the date of receipt of the firm order.

#### 14. CERTIFICATE

Rate contract documents should be accompanied with latest BIS Certificate permitting use of BIS mark, Income and G.S.T. returns Certificate. The offeres should not entertained in absence of above Certificates.

#### 15. PAYMENT:

Payment of the material/bill will be made within 30 days from the date of receipt of Material in good condition/bill which so-ever is later.

#### 16 CONDITIONAL OFFER

The Managing Director reserves the right to reject any offer with any condition not earlier specified in the offer documents by the corporation.

# 17. ACCEPTENCE OF OFFER

(i) The Managing Director of the corporation reserves the right to accept or reject any or all the offer fully or partially without assigning any reason whatsoever at any time prior to the award of the contract, without incurring any liability to the affected Offerer and any obligation to inform the affected Offerer of the grounds. The decision of the Managing Director will be final and binding on all concern. (ii) The Offerer is expected to read carefully all instructions, conditions of RCO Document appendix to RCO, Performa agreement, specifications annexure and schedules in the RCO documents. Failure to comply with the requirements of offer submission will be at the Offerer's risk. Offer, which is not substantially responsive to the requirements of the RCO documents, will be rejected.

#### 18. VALIDITY OF OFFER AND GUARANTEE.

- i. The offer should be valid and open for acceptance for period of 120 days from the date of opening of RCO. Failure to sign the RCO shall result in rejection of the offer
- ii. The offerer whose rates are accepted by the Corporation and execute an agreement should be valid for one year or till to execute new agreement.
- The stock supplied by the supplier shall carry one year guarantee against any manufacturing defects from the date of actual sale, in case of any such defect detected during period of guarantee the supplier shall have to arrange replacement of defective parts within 15 days from the receipt of notice issued by the Corporation, otherwise the Corporation may arrange replacement.

#### 19. PRICE FALL CLAUSE

The price charged for Biogas Accessories supplied under this contract by the offerer shall in no event exceed lowest price at which the offerer sells the accessories of identical description to any other persons/ organization /Govt. or semi govt. body in M.P. during the period till performance of all order during the currency of contract is completed.

In case the offerer reduces the price or quotes or sells similar items at a rate lesser than the rates offered to Corporation to any person during the currency of contract, the same lower rates will stand applicable to this Corporation also from the same date. The offerer shall have to inform the Corporation about such reduction in rates.

# 20. NEGOTIATIONS

It is clarified that normally the Corporation will make no negotiation on the offer and therefore the offerer should quote their lowest prices only. However the Managing Director of the Corporation may decide to give counter offer of lowest rates to those offerers whose offer rates are within the limit of L-1+15%.

#### 21. EXECUTION OF AGREEMENT

- (a) The Corporation shall intimate the successful Offerer regarding acceptance of his offer and inform him to execute an agreement. In case the Offerer fails to execute agreement within 15 days limit from the date of communication regarding acceptance of his offer, the Corporation will decide to the EMD deposited by Offerer shall be forfeited and offer of lowest approved rate will be given to the offerer who have quoted 2<sup>nd</sup> lowest rate and after accepting counter offer Corporation will execute an agreement.
- (b) The successful Offerer shall have to execute an agreement as per Annexure-2 with the corporation. The agreement will be executed on non judicial stamp paper of Rs. 1000/-.(cost of the same will be bear by the offerer).
- c) After executing the agreement, offerer will be known as Supplier.

# 22. SCHEDULE AND MODE OF SUPPLY / DELIVERY.

- (a) Order for supply will be issued by Head office for that quantity which can be sold within 30 days and the payment will be made by H.O. within 30 days from the date of receipt of material/bill, which so ever is later.
- (b) Ordered item will be supplied to the consignee through District Manager office of the Corporation in M.P.
- (c) The Offerer has to supply/deliver the ordered quantity to destination, in good condition and as per specifications as given in RCO, within specified period mentioned in the order. Failure on the part of the supplier for timely supply without proper acceptable reason, shall lead to forfeiture of Earnest Money, the offer shall stand cancelled, and agreement will be terminated and the supplier will be debarred for further rate contract for the period of one year as decided by the Managing Director of the Corporation. Corporation can also claim loss of goodwill as deemed fit by it and the same shall be payable by the supplier.

# 23. SECURITY DEPOSIT

The Earnest Money Deposit will be retained from the firm which is registered as a prospective supplier as Security Deposit. The Security Deposit will be refunded after the successful execution of order and after the expiry of the contract period or expiry of validity period whichever is later provided no dispute, claims or complaints exist for settlement and no interest shall be payable by an amount of security deposit.

- **24**. In case of any dispute arising between the supplier and MP Agro the matter shall be referred to Managing Director of the Corporation who will act as sole arbitrator finally passes his verdict, which will be binding on supplier, and Corporation.
- **25.** The rates so approved by this RCO will be applicable up to 31-03-2026 and onwards. The RCO can be extended after the expiry i:e 31-03-2026 till the new Rates are circulated after finalizing the New RCO in this regards.

Only Bhopal Court shall have the jurisdiction.

AGREEMENT

(Herein after called party No. 1) and M.P. State Agro Industries Development Corporation Limited "Panchanan" 3rd Floor Malviya Nagar Bhopal, (Herein after Called Corporation/Party No.2) which expression shall include their heirs representative executors and administration respectively.

Whereas the Party No. 2 invited offers for supply of Biogas Accessories \_\_\_\_\_\_and party No. 1 has submitted rate contract documents accepting the terms and condition of the offer laid down there in at the rates, i,e Rs \_\_\_\_\_ for \_\_\_\_ ( Biogas Double Stove/Single Stove / Indoor Lamp/ S.S.Ball valve/ 20 mm HDPE pipe/ Epoxy Point ) exclussive of GST \_\_\_\_% FOR Destination head quarters anywhere in Madhya Pradesh levies shall remain in force till 31-03-2024 or till the new rates are circulated.

Whereas the party NO. 2 has accepted the offer of Party No. 1 for the supply of Biogas Accessories on the rates mentioned herein above.

Now these present witnesses and the parties hereby agree as follows:-

- 1. All the terms of conditions of this RCO Document are the part of this agreement
- 2. That the Earnest Money, which the Party No.1 has deposited at the time of submission of offer shall be deemed as Security Deposit for the purpose of due performance of this agreement and the Party No. 2 shall have the right and authority to forfeit the same in case of breach of the terms & conditions contained herein and shall have further right to impose such penalty as may be found necessary and fit in circumstances.
- 3. That the party No.1 (in case of BIS marked accessories.) shall have to ensure the supply of only approved ISI accessories in good condition manufactured by them in their own factories. These accessories shall be of BIS Mark in case of non ISI marked accessories the Party No. 1 shall have to ensure the supply of only approved accessories in good condition. If at any time it is found that the accessories supplied are of sub standard quality damaged or unserviceable or not confirming to the specification mentioned in the rate contract approval/supply order. The Party No. 1 shall have to replace them immediately at their own cost within 15 days other wise the party No.2 shall have the right to withhold the payment of the bills of such accessories If the accessories or not replaced within a period of 10 to 30 days the Party No.2 shall have the right to deduct up to 5% the cost of bills of such items. However If delay in replacement is beyond that period of 30 days the supply order issued shall be deemed to have been revoked at the cost & risk of Party No. 1.
- 4. That the Party No.1 shall have to supply the accessories as per directives/instructions given by Party NO. 2 or officers authorized within 7 days from the date of order during the period of contract as mentioned in supply order.
- 5. That the party No.1 or his dealer/agent shall not supply the accessories to any other person or party at lesser rates than those at which they are being supplied to Party No.2 In case of deviation from this clause/condition Party No. 2 shall

have the right to recover the amount of such differences in rates from Party No. 1 and shall have further right to cancel the contract and forfeit the security deposit.

- 6. The terms & conditions for making payments will be as follows.
- 6.1 The orders will be placed by H.O. of party No.2 for that quantity which can be sold within 30 days and the payment will be made by Head Office within 30 days from the date of receipt of material/bill which so ever is later.
- 6.2 From the field on the random basis the samples of the items supplies by the party No.1 will be sent for testing by the branch office of the party No.2 and the action on the basis of test reports viz. to continue/discontinue this agreement to return/use the supplied items by the party No.1 to impose penalty on the party No.1 will be taken by party No.2. The test fee will be borne by the party No.1.
- 6.3 To ensure quality of the products the Party No.2 shall be fully empowered to draw samples at any time and send the same to the recognized laboratory of testing in case the report is found to be sub-standard. The Party No.2 shall be entitled to forfeit the Security Deposit and terminate the agreement besides initiating action as deemed fit for black listing of the Party No.1
- 7. In case of breach of any terms & Conditions of this Agreement or of those mentioned in the tender documents or conditions specified in supply order or otherwise the party NO. 2 shall have the right to cancel the contract, terminate the agreement an forfeit the security deposit/Earnest money. In case of any loss suffered by the party No. 2 from such an action or breach by the party No.1 the party No. 2 shall have further right to recover such amount of loss from Party No.1 in such a manner as the Party No.2 may deem proper and legal and the Party No.2 will indemnify the losses if any.
