B. SCOPE OF WORK:-

The Corporation has Bio Fertilizer Plant at Agro Complex, Indrapuri, Bhopal, presently producing Powder based bio Fertilizer. We want to start production of liquid bio fertilizer, for this purpose tender is invited for following items-

1 Aseptic gravity filling, capping, labeling and batch printing machine - automatic

- a. Tenders are invited for Supply and installation work for Aseptic gravity filling, capping labeling and batch printing machine include supply of bottling machine, capping machine as per Annexure 7. All needs to be connected with existing 4 main fermentor and providing proper out let space for handling of filled bottles.

The tenderer are requested to visit site before submission of tender and get aware with actual requirements and condition.

For supply, installation and commissioning of above equipment ensuring aseptic condition, technical civil work/ electrical work, if any required, will be at the scope of supplier. Any such civil, electrical work should be done in such a manner that the existing plant/ floor/ electrical connection should not get damage, else supplier shall be responsible to replace/ repair the same.

TERMS AND CONDITIONS OF TENDER.

01. GENERAL TERMS AND CONDITIONS :

I. AVAILABILITY OF TENDER DOCUMENT

- a) The tender documents are available on website www.mpagro.org of the corporation, & on www.mptenders.gov.in .
- b) Tender Documents can be purchased by paying on line payment Rs 2950/- (Including GST) and service charges of portal on www.mptenders.gov.in against the cost of document.
- c) Any amendment(s) in tender document including extension of date etc., such amendment(s) will be hoisted on the Corporation's website www.mpagro.org & on www.mptenders.gov.in. No further notification will be published in the news paper. Accordingly interested bidders are advised to keep close watch on the Corporation's website in their own interest. It is also to be noted that any such amendments will be part of Tender.

II. STAGES AND DUE DATES FOR TENDER-

The stages of bidding with important dates has been mentioned at point C and E (page no 5, 6)

III. TENDER DOCUMENT

The Tender document comprises of 21 pages (Annexure 1,2,3,4,6,7 and 8 and are common and Annexure 5 is for being distributor. Tenderer is expected to read carefully all annexure and conditions mentioned herein. Failure to comply with the requirements of submission of offer will be at the tender's risk. Bid that is not substantially responsive to the requirements of the Tender documents will be rejected.

IV. SUBMISSION OF TENDER.

- a) Tender has to be submitted on-line, on website www.mptenders.gov.in on or before due date and time, mentioned at page no 5.
- b) All the Mandatory Documents to be uploaded (Self Certified with Seal and signature) as per list in Point G at page no 6-7 shall be uploaded in JPG or PDF format only, in minimum resolution of 100 DPI or above. Document uploaded in other format will not be considered.
- c) Self attested hard copies of all documents as mentioned in point G must be dropped in Tender drop box placed at Office of the In charge, Bio Fertilizer Plant, M P State Agro Industries Development Corporation Limited, C- Sector, Indrapuri, Bhopal, on or before due date and time.
- d) The Envelope of Hard Copies shall be submitted in a sealed cover super scribed with words **"Tender for supply of ----- Technical information regarding eligibility"**

Envelope should contain the following documents:-

- (i) Tender Document with all annexure duly filled and signed on each page by authorized signatory. Manufacturing Registration Certificate (License/ Acknowledgement EM Part II/ Udhog Adhar) issued by District Trade Industries Centre (DTIC) or Statutory Competent Authority for manufacturing of Plant and Machinery.
- (ii) Self Certified Copy of Valid PAN and GSTN (of Manufacturer and Authorized Distributor as the case may be).
- (iii) Affidavit as per Annexure 4 at **page no 16**.
- (iv) In case of Authorized Distributor valid Authority to submit the Tender to this Corporation in Down Loaded Colored Printout / original (as per Annexure 5 at **page no 17**)
- (v) Authority to sign Tender (In Case of Partnership/ Proprietorship firm as per Annexure 9/ In Case of Pvt. Ltd/ Ltd Company copy of Board Resolution has to be submitted along with Annexure 9) as per Annexure 9 at page no 21
- e) Hard Copies received in the offer box up to due date and time will be opened on due date and time as mentioned point in **page no 5**. In case of any non clarity of uploaded documents or any dispute over documents uploaded online in e-Tender, the hard copies submitted by the Tenderer shall be treated final. The Corporation can take hard copies/ uploaded documents in consideration in exigencies required to do so.
- f) The Corporation is Not responsible for non submission of Tender due to any unseen reasons like server downs, network problems etc. Tenderers are advised to submit their Tender well in advance before last date and time of submission to avoid such problems.
- g) The Corporation will not be responsible for any delay on any account in receipt of hard copy of Tender, even if the delay in receipt was caused in postal transit or any other reason, whatsoever.
- h) On-line Tender will be opened on due date and time as mentioned at **page no 5** in the presence of the representative of firms who wishes to be present. However if the date and time of opening of Tender is changed due to any unforeseen reason the revised date and time of opening will be uploaded on Portal/ website of the corporation.
- i) Not more than one tender for one item will be accepted from any Applicant/ Manufacturer. If any individual participating in the offer, representing more than one firm in one or different names and it comes to our knowledge at any point of time, all such offer will not be entertained and shall be liable for rejection.

02. EARNEST MONEY DEPOSIT (EMD):

Tenderers has to deposit required Earnest Money has to be deposit on line on www.mptenders.gov.in

- (i) Earnest Money of all unsuccessful Tenderers will be returned by www.mptenders.gov.in directly in the same account of the applicant. No interest is payable on the amount of EMD at the time of refund.
- (ii) Earnest Money shall be forfeited if the offer is withdrawn.
 - a. At any time prior to its rejection.
 - b. Before or after the acceptance is communicated to the Tenderers.
 - c. If the selected Tenderers fails to execute the agreement within prescribed time limit.
 - d. If it is found that false documents/ information are submitted.
- (iii) The EMD will remain with the Corporation during the currency of the contract and/or till successful execution of all the order placed against this tender and will be refunded to the supplier without interest in case of no dispute.
- (iv) Earnest money of successful Tenderers will be adjusted against Security Deposit (SD) at the time of the execution of the agreement.

03 SECURITY DEPOSIT (SD):

- (i) The Security deposit will remain with the corporation during the currency of the contract (up to the end of warranty period) and will be refunded to the supplier after execution of the work order issued under this contract, without interest in case of no dispute.
- (ii) Security deposit will be forfeited in case of failure of supply of the material as mentioned in the purchase order, in time and as per the approved specifications or for any breach of terms and condition of the agreement and Tender documents.
- (iii) The security deposit will be refunded on demand after the successful execution of all orders provided no dispute, claims or complaints exist for settlement without interest.

04. TECHNICAL SPECIFICATION:

Technical Specifications of Items are given in Annexure 7 at **page no 19**. Supplier has to supply, install and commissioning of items as per the specification mentioned according to the Scope of Work on turnkey basis.

05. QUOTING OF RATES:

- a) The Tenderer must submit rates online only as per format given in Annexure 8 at **page no 20**. This Format of price schedule is a sample for the Tenderer. The Tenderers are instructed to fill the rates in prescribed price schedule available on portal.
- b) Tenderer has to quote online only the supply rate per unit (as mentioned in Annexure 8) inclusive of all taxes and F.O.R. destination (Bio Fertilizer Plant Indrapuri Bhopal) including unloading and Installation charges on turnkey basis. Rates exclusive GST and inclusive GST should be mentioned as per annexure 8.
- c) Tenderer has to indicate GST% and relevant HSN Code in relevant column of annexure 8.
- d) The Tenderer should quote their lowest price, in accordance to the condition mentioned in clause No. 6.
- e) In Case of Taxation rates / Taxation Pattern are revised by Central/ State Govt. the same will be applicable.

06. REASONABILITY OF RATES:

Tenderer shall have to offer his lowest rates and it should be strictly in accordance with the clause mentioned below (applicable from the date of Submission of Tender).

- a) The price charged for Item under this contract by the Tenderer shall in no event exceed the lowest price at which the identical items to any other person /organization/ Government department/ Govt. Corporation / or any Govt. body in Madhya Pradesh during the period of contract till completion of all orders issued during the currency of contract.
- b) At any time during the aforesaid period, If the Supplier reduces unit sale price of such offered item or sells such items to any other person / organization at a price lower than the price chargeable under the contract, the Supplier shall forthwith notify such reduction in the rate to the Corporation.
- c) After such reduction in unit sale price, the amount paid under this contract to supplier shall be reduced correspondingly & the Corporation shall be entitled to recover such excess amount from the supplier's forthcoming bills.

07. NEGOTIATION: It is clarified that normally, no rate negotiation will be done and therefore the tenderer should quote their lowest prices only. However if rate received is not reasonable than on recommendation of committee, the Managing Director of the Corporation may decides to give counter offer of the rates decided by the corporation to L-1 Tenderer. In Case the L-1 Tenderer is not agree on counter offer rates, the corporation may decide to give counter offer to L-2 Tenderer.

08. VALIDITY OF BID: Applications received against this Tender shall be valid for acceptance for 6 months from the due date of Submission of Bid.

09. EXECUTION OF AGREEMENT:

- a) The Corporation will intimate the successful Tenderer regarding acceptance of his offer and inform him to execute an agreement. In case the tenderer fails to execute agreement within time limit the EMD deposited by tenderer shall be forfeited.
- b) The successful Tenderer shall have to execute an agreement as per Annexure 6 at page no 18 with the Corporation. The agreement will be executed on non-judicial stamp paper of Rs. 1000/-, the cost of the same will be borne by the Tenderer.

10. PROCEDURE & TIME SCHEDULE FOR SUPPLY OF MATERIAL:

- a) As per the time schedule stipulated by the Corporation, it is necessary that the all the materials and equipments are to be supplied at the destination within 30 days from the date of order. Further 30 days will be allowed for installations i.e. total 60 days will be allowed for a trial run from the date of order.
- b) It is the responsibility of the supplier to effect quality supplies as per the order.
- c) In case, the supplies are delayed by the supplier, the loss caused to the Department /Corporation due to delay, the supplier will be made responsible for which the recovery of the loss amount will be made from BANK GURANTEE of the supplier, depending upon the cost of the material. The amount to be recovered will be decided by the Managing Director of the Corporation and it would be binding on the supplier.

11. ORDER PROCEDURE:

- a) The orders issued by the Corporation for supply of the Item are subject to change regarding date. If any changes are there, they will be communicated to the supplier. According to new schedule, the supplier has to supply the plant at the approved rate. If unexpected changes take place, the Corporation will not be able to pay extra amount for the plant.
- b) Any damages/ breakdowns or losses caused during transportation of material or loss occurred due to theft, fire accident, breakage etc. the supplier will responsible and will bear the loss and the Corporation will not be responsible. It is advised that Tenderer should take necessary insurance coverage.

12. QUALITY

- a) Any material if not found conforming to the quality specifications, the same shall be liable for rejection, after having rejected the Corporation shall also be eligible to recover all the losses incurred and the losses which may likely to be incurred as deemed fit due to such rejection.
- b) If Corporation feels that material supplied is not as per the quality parameters / specifications as mentioned in the tender document / in supply order then, Corporation can decide to get it tested from the any government / reputed / BIS laboratories or laboratories accredited by NABL (National Accreditation Board for Testing and Calibration Laboratories) at the risk and cost of the Supplier and/or refuse the accept supplies.
- c) The Corporation can however also decide to ask the supplier to replace the rejected material and the material shall have to be replaced immediately at his own cost by the supplier within 7 days of time of receipt of intimation either written or verbal. In case defective material is not replaced within given time limit, the Corporation will be free to remove such material at the cost & risk of supplier and expenses incurred for the same will be liable to be deducted from security deposit or from any other amount due to the

party concerned. No responsibility physical or financial shall be attached to the Corporation for the safe custody of material / materials supplied in excess as per delivery schedule communicated to them or quantity not conforming to specifications or rejected or supplied in advance.

13. AUTHORITY FOR ACCEPTING/ NON-ACCEPTING OF THE ITEMS OF THE PLANT:

It is necessary that the supplier has to abide the instructions for supply of the items of the Items within time stipulation. A committee for quality inspection will be formed, whose decision will be final. As per decision of the committee the supplied item can be rejected in the following conditions:

- a) If the supplied items are not in accordance with specifications or ordered quantity.
- b) In case, the consignment is received after expiry of time schedule.
- c) In the above circumstances, if the consignment is not accepted, the supplier has to take back the same as per the time schedule indicated by the Corporation at its own cost. Under any circumstances, the Corporation will not be responsible for any loss occurred due to return of goods.

14. WARRANTY : Warranty will be THREE YEARS from the date of successful trial run.

The supplier shall remain responsible against any manufacturing defect and malfunctioning of any equipment /instrument/ Automation/ Electrical installation. The same is required to be replaced / repaired with same make and brand within 3 days from the date of complaint in writing by the factory in charge.

15. PAYMENT SCHEDULE

- a) 50 % payment will be made normally within 30 days from date of receipt of material on submitting verified bills. from the date of receipt of material along with bills (in triplicate) complete in all respect (basic price of the material supplied and GST to be mentioned separately as detailed in the order mentioning the Corporations GSTN on the bill).
- b) Balance 40 % payment will be made normally within 30 days from date of **SUCCESSFUL TRIAL RUN** on submitting verified bills.
- c) Remaining 10% Payment will be made on submission of Bank Guarantee of 10% of the value of the total order valid for 3 years. The Bank Guarantee will be released only after 3 years from the date of successful trial run i.e. on completion on warranty period.

Or

Remaining 10% Payment will be made only after 3 years from the date of successful trial run i.e. on completion of warranty period.

16. PENALTY:

- a) The supplier shall have to supply the goods as per direction / instruction given by the Consignee in the supply order or from time to time in writing / orally. In case the goods are not received within time limit given or so communicated to them, then the Corporation will be free to procure the ordered material from any other source on the cost and risk of supplier. In such event, the price difference or any other loss can be recovered from the supplier. The Corporation will have right to cancel the contract and forfeit the security deposit and recover all losses due to such misconduct of the supplier.
- b) If the item supplied is of sub standard quality, the Corporation shall be entitled to recover the damages as deemed fit and take any other suitable action against the supplier.

17. PURCHASE FROM SC/ST CATEGORY ENTREPRENEURS: As per the state Govt. Policy, if the SC/ST entrepreneur participate in the tender and submits certificate of special caste category of SC/ST from concerned Departments and fulfills the terms & conditions of the tender.

18. Once the Bidder submits the tender, it is understood that Bidder has gone through all the terms & conditions of the tender and accepted them. The Bidder should sign with seal impressed on all the documents of the tender.
19. The Managing Director of the Corporation reserves the right to amend/modify partially/completely or repeal the terms & conditions of the tender if exigencies required doing so without any notice, any time before the bid due date.
20. **SETTLEMENT OF DISPUTES:** Any disputes or differences, which may arise between Bidder and Corporation, it is to be amicably settled and the Managing Director of the Corporation will be the arbitrator. If amicable settlement cannot be reached, the court of Bhopal only shall have the jurisdiction to deal with and decide any legal or dispute arising between them.
21. **FORCE MAJEURE CLAUSE:** If at any time during the currency of contract the performance in whole or in part by either party or any obligation under this contract is prevented /delayed by reasons of any war, hostility, acts of the public enemy, civil commotions sabotage, fire, floods, explosions, epidemics, quarantine, restrictions, strike. lockouts or due to any reason beyond human control (hereinafter referred to as eventualities) then neither party will be way of such eventuality be entitled to terminate this contract nor shall have any claim for damages against the other in respect of such non performance or delay in performance (provided notice of the happening of any such eventualities is given by either party to the other within 21 days from the date of occurrence thereof) Deliveries under this contract shall be resumed as soon as practicable after such eventualities has come to an end or cease to exist.
22. The Managing Director of the Corporation subject to clause 16 (PENALTY) mentioned above may extend time limit maximum up to 4 weeks and imposing penalty up to Rs 5000 per week of such delay.
