INSTRUSTRICTION TO BIDDERS FOR ONLINE RATES

1. Only Registered Suppliers, who have participated in online tender procedure of Registration of Various Raw and Packaging Material for the year 2019-20 and onward through www.mptendes.gov.in and Executed Agreement with the Corporation for year 2019-20 and onward) are eligible to quote online rates.
2. Rates received from unregistered / rejected bidders will not accepted.
3. Since, all registered bidders already submitted Tender Document Fee and EMD at the time of online registration, they need not to pay it again. Only Processing Fee is to be paid online. Though, there are no provision in www.mptenders.gov.in poratl to keep zero amount of EMD and Tender Document Fee, it has been kept Rs. 1 instead of zero. Also, exemption is allowed for registered bidders. They can avail exemption option to avoid online payment of EMD and Tender Document Fee.
4. Applicable GST percentage is indicated in column no. 12 of BOQ (price bid excel sheet). Basic Price and GST Amount to be enter by the bidder in relevant column.
5. Prices are F.O.R. destination including of all Taxes and Loading/unloading charges for Badi, Mandideep, Indore and Dewas Plant rates are inclusive of all Taxes and Loading charges only. Unloading will be done by the Plant itself.
