

This clause would restrict the participation and most of them will be deprived of getting themselves registered with the Corporation. Therefore, this condition should be relaxed. | Query raised is being considered so as to facilitate maximum participation in the registration process, corrigendum to this effect will be issued separately. |

| 3 | VITAMIN & MINERALS PREMIX | DSM Nutritional Products, Gurgaon At Page No. 34 Table Sr. No A- 2 Iron (mg) (Ferrrous Fumarate, IP) should be replaced by Ferric Pyrophosphate or Sodium Iron EDTA. At Page No. 34 Table Sr. No B-1 Vitamin A (mcg) (Dry Acetate, IP) Should be replaced by Retinyl Palmitate. | Necessary changes will be made after obtaining Clarification from Directorate of Women and Child Development. |
| 4 | FORTIFIED RICE KERNELS (FRK) | M/s JVS Foods Pvt Ltd, Jaipur As Fortification of rice is very new in Govt. Schemes, Regulations for fortification of food were issued on Aug 2 nd 2018, and Ministry of Women & Child Development, GoI on 28-2-2019 made the use of Fortified Rice mandatory in supplementary Nutrition Program under Anganwadi Services Scheme. Hence Experience condition should be changed to "In Last two financial years 2018-19 and 2019-20 of 100MT". | Query raised is already addressed in point no. 1 above. |

At Page No 36 Table Sr No 3 Vitamin A (mcg) (Dry Acetate, IP) Should be replaced by Retinyl Palmitate. | Necessary changes will be made after obtaining Clarification from Directorate of Women and Child Development. |
